About the Program

Are you a penultimate (second last) or final year student interested in corporate finance, mergers and acquisitions, and capital markets?

Do you want to experience what it's like to work on a real-life corporate finance transaction?

Would you like to learn more about life at Barrenjoey?

Take this opportunity to apply for the Barrenjoey Future Principals Program (**the Program**). Through a series of case studies based on real-life transactions, we will challenge you to research, solve problems, think critically, and demonstrate commercial judgement – just like we do at Barrenjoey every day.

The Program is structured in three rounds:

- 1. Application: CV and academic transcript submission.
- First Round: Short case study response follow ed by a 15-minute Q&A on your submission (virtual).
- Final Round: Group case study assessment, individual interview s and netw orking opportunities at Barrenjoey's Sydney office.

What's on offer?

Finalists will be invited to Barrenjoey's Sydney office to participate in a final group case study and interview s, meet our team, experience life at Barrenjoey and win the opportunity to be fast-tracked through our Corporate Finance Intern or Graduate recruitment processes (as applicable).

Those chosen to take part in Barrenjoey's Internship or Graduate Programs will also receive the Barrenjoey Future Principals Program scholarship, which includes ongoing mentorship from the Barrenjoey team and payments as follow s:

- Penultimate students: A\$2,500 payment for those w ho commence as interns and a further A\$2,500 for those w ho commence as graduates follow ing their internship¹.
- Final year students: A\$2,500 payment for those w ho commence as graduates¹.

What's the process?

- By 5pm AEST on Monday, 1 May 2023, apply with your CV and academic transcript <u>here</u>.
- On Monday, 8 May 2023, successful applicants are notified and receive the First Round case study via email.
- 3. By 7pm AEST on Monday, 15 May 2023, First Round applicants submit their response to the case study.
- On Thursday 18 May or Friday, 19 May 2023, First Round applicants virtually meet with a panel of Barrenjoey judges for a 15 min Q&A on their case study response.
- On Friday, 26 May 2023, successful applicants are progressed to the Final Round to be held at Barrenjoey's Sydney office².

Should you apply?

We invite penultimate (second last) and final year students from any Australian university to apply. The Program is designed so that <u>students in any degree or major can</u> <u>participate</u>, not just those studying finance.

- Applications close: Monday, 1 May 2023, 5pm AEST
- First Round case study release: Monday, 8 May 2023
- First Round submission: Monday, 15 May 2023, 7pm AEST
- First Round Q&A: Thursday 18 May Friday, 19 May 2023
- Final Round: Friday, 26 May 2023, full day

Key questions you may have

What is a Principal?

At Barrenjoey we don't believe in multiple rank-based layers or grades – they constrain high performers. There are only two levels at Barrenjoey: Principal and Partner.

What happens after I submit my initial application?

The Barrenjoey team will review applications and email all applicants with an outcome by Monday, 8 May 2023. Successful applicants will be invited to participate in the First Round and will receive the First-Round case study and instructions.

How will the case studies be assessed?

The Barrenjoey team will judge the case study responses and Q&A on a range of criteria, including content quality, strategic and creative thinking capability, presentation skills and communication skills. Further details on assessment criteria will be disclosed in the instructions of each round.

What happens to case studies which aren't progressed?

Case study responses will not be used for any other purpose outside of the Barrenjoey Future Principals Program.
